The WCCS first gathered as a congress at Logan College (USA) in 1980 with 11 Chiropractic Colleges represented. The growth of the organization over the years has been remarkable, and reached its peak at the 39th Annual General Meeting (AGM) in 2019 in Brisbane, Australia, with approximately 150 chiropractic students and new graduates representing over 30 chiropractic colleges and universities from around the world.

As an apolitical non-profit organization, we strive to offer chiropractic students a platform to enhance leadership and advocacy skills, while gaining a deeper understanding about the diversity within the chiropractic profession.

Receipt

Therefore, we recommend consulting with a local tax advisor or accountant to confirm the eligibility of your sponsorship for a deduction.
